



UTILITIES TARIFFS COMMENCING 1 JULY 2024 TO 30 JUNE 2025

The Utilities Regulatory Authority (URA) has authorised increases of 15% in electricity charges and 10% in water charges with effect from 1 July 2024 up to 30 June 2025. There are no changes to sewerage charges at this time.

Tariffs were last changed on 1 January 2024, covering the period up to and including 30 June 2024. These were temporary tariffs implemented for the six-month period whilst Connect Saint Helena Ltd (Connect) was requested to provide an updated tariffs proposal. Prior to that, electricity tariffs had been revised in 2016 and water and sewerage tariffs were revised in 2021. This reflects a considerable period where there had been no adjustment to utility prices whilst costs have escalated.

In April 2024, the URA commenced consultation on tariff proposals. Three options were considered, two from Connect and a third that the URA had derived.

Following public consultation and review, the URA adopted Option 2 for electricity. This means that electricity charges will increase by 15%. The current tariff structure has been retained whereby domestic usage below 1000 units per quarter is charged at a lower rate. Domestic usage above 1000 units per quarter as well as commercial and three-phase usage will be charged at a higher rate.

Water charges have been increased by 10%. The current tariff structure has been retained. For example, for domestic consumers, there is a standing charge as well as three bands for treated water usage.

In addition to setting electricity and water charges for the period 1 July 2024 to 30 June 2025, the URA has provided guidance on plans for tariffs from 1 July 2025. We will cover these in a separate update.

The agreed increases are necessary in light of cost escalations, not only in the current operating environment but also historically given the length of time that had elapsed prior to tariffs being adjusted in 2024. Connect encourages all concerned customers to speak to our Billing Section.
